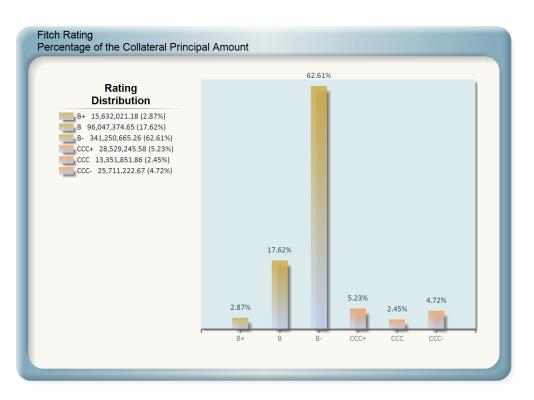

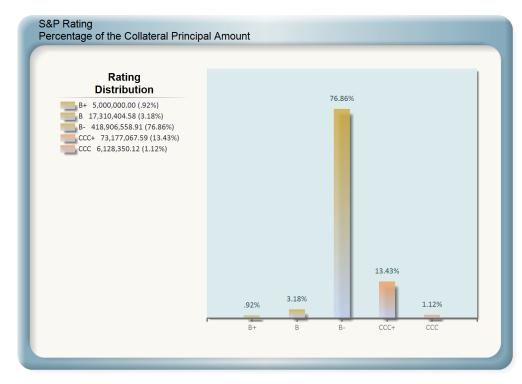

#### Risk Retention
